REGULATIONS

- ◆ All exhibits must have NLIS PIC tags
- ♦ No sheep will be allowed on the property of the Royal Agricultural Society, which comes from a property, which is under quarantine for foot rot or any other reason. All sheep entered in these Classes must be Tasmanian-bred, & the bonafide property of the exhibitor for at least 3 months preceding the Show. Any lamb which has evidence of permanent incisors will not be judged. Ram Lambs are ineligible.
- ◆ In addition to any special regulations herein all Exhibitors in this section are subject to the General Regulations for Competitors and Exhibitors of the Royal Agricultural Society of Tasmania, copies of which are available on request from the Society.
- ◆ IDENTIFICATION OF LAMBS: Exhibitors are advised to have an identifying mark on each group by class of lambs entered. To avoid devaluation of the skin, Syromark should be on the head of the lamb.

CLASS 1 - TRADE LAMBS:

Weight range – Up to and including 45 kg.

ROBERTS PERPETUAL TROPHY – Available for competition only if 5 or more entries are received in this class & exhibited. The Trophy to be returned to the Society by the holder before 1st October each year.

CONDITIONS:

- Each entry to consist of 1 pen of 3 lambs best suited to the trade. Details of breed or cross are to be stated in the exhibitor's entry form, together with date of birth.
- Lambs to be weighed on delivery to Showground and before judging commences. Maximum average live-weight up to and including 45 kg.
- Entries will be weighed for average weight of class.
- Entries not conforming to the weight range of the Class will be automatically transferred to the appropriate class.
- Over trimmed lambs may be disqualified at the discretion of the judge, but it is desirable that stains & dags be removed.
- ♦ All wool lengths acceptable.
- ◆ To be judged for conformation, skin value, evenness of pen & general suitability.

CLASS 2 - HEAVY WEIGHT PEN OF THREE LAMBS.

- ◆ To be competed for in a class for prime lambs suitable for heavyweight trade.

- Lambs to be weighed on delivery to Showground and before judging commences.
- ◆ The lambs must have a minimum average live weight of 45.1 kg. Entries will be weighed for average weight of class.
- ◆ Entries not conforming to the weight range of the Class will be automatically transferred to the appropriate class.
- Over trimmed lambs may be disqualified at the discretion of the judge, but it is desirable that stains and dags be removed.
- ♦ All wool lengths acceptable.
- ◆ To be judged for conformation, skin value, & suitability.
